Para las personas sin seguro, los costos de las pruebas serán cubiertos por el estado / If the person being tested has insurance, the insurance company will be billed. For uninsured individuals, the testing costs will be covered by the state.

Appointments are available Monday-Friday, 7:00am to 7:00pm. Insured individuals will be billed to their insurance. Uninsured may be paid by the state.

Stallant Health (Weimar) established patient just schedule visit. New patient process: must determine eligibility, must register with Stallant Health, and then schedule appt. Uninsured patients: initial visit is \$135, COVID test is \$100.

Sutter Health (Roseville, Auburn): must meet CDC criteria to be tested. advice line: (866) 961-2889 from 8:00 am – 5:00 pm. All ADMITTED patients will be tested for COVID.
